

ACM30321 - CERTIFICATE III IN WILDLIFE AND EXHIBITED ANIMAL CARE

Nationally Recognised Training

This qualification reflects the skills and knowledge required for individuals undertaking a range of animal care functions in a zoo, wildlife sanctuary, aquaria or other facility where animals are cared for or exhibited. It applies to individuals who undertake activities autonomously or in teams working under broad direction. Activities may include individual animal welfare to social group management in small to large scale facilities.

CAREER PROSPECTS

When you complete the Certificate III in Wildlife and Exhibited Animal Care graduates will be qualified to apply for various positions including Zookeeper/Animal carer, Native wildlife carer, Wildlife rehabilitator, Animal technical officer, Aquarist..

ARTICULATION

Students who successfully complete the Certificate III in Wildlife and Exhibited Animal Care can gain credits for subjects included in the ACM40221 - Certificate IV in Animal Facility Management if they decide to continue their studies. Under the Australian Qualifications Framework (AQF) Certificate III is AQF Level III.

<u>AWARD</u>

Upon successful completion of all units of competencies in the course, students will be issued with a Certificate III in Captive Animals. Should a student not complete the entire course then a Statement of Attainment will be given for the units successfully completed.

ENTRY REQUIREMENTS

There is no age limit, but applicants should have successfully completed year 10. Mature age and students with prior learning and experience should also apply.

DELIVERY OF THE COURSE

The Certificate III in Wildlife and Exhibited Animal Care is delivered through approximately 78 week course of practical experience and theory.

For those currently working in the industry it can also be delivered by on-the-job training, off-the-job training and by the 'self paced' method of learning which allows you greater flexibility in choosing the times you study and the time it takes you to complete the course.

ASSESSMENT STRATEGY

Assessment in this course will be competency based, in that the student will be required to demonstrate competency in a range of tasks. The assessment coding which will apply is either C or NYC, where C is Competent, and NYC is Not Yet Competent. Assessment procedures are transparent and address the key assessment principles of being valid, reliable, flexible, fair and cost effective. Assessment strategies encompass a range of techniques, which include, but are not limited to the use of:

- Direct observation of performance
 Oral questioning
- Simulations of workplace activities
- Practical exercises
- Projects/assignments
- Work portfolios

RECOGNITION OF PRIOR LEARNING & CREDIT TRANSFER

Students who can demonstrate that they are already competent in the knowledge and skills of a unit of competency, or have previously completed a course with another Institution, may apply for Recognition of Prior Learning (RPL) or Credit Transfer.
